# Call for Expression of Interest for a National Expert (Namibia)

Deadline: 4 May 2020

The purpose of this call is to solicit expression of interest from individuals interested in working as a national expert (Namibia) in the implementation of the above-mentioned project.

Interested candidates are requested to submit to Ms Anaïs Chagankerian (a.chagankerian@unesco.org), by **4 May 2020**:

- a **detailed CV** providing evidence that they possess the required skills and professional experience described in the terms of reference;
- an application form (Annex 2);
- a financial proposal (Annex 3).

# **Selection process**

The candidates will be evaluated by UNESCO in cooperation with the Ministry of Education, Arts and Culture of the Republic of Namibia. **Short-listed candidates might be invited for a phone interview**.

A selected candidate will receive a **consultant contract** from UNESCO to carry out the terms of reference provided below. S/he will be expected to undertake substantial amount of desk research to capture the context of Namibia's creative sector and existing policies, support the Namibian Government and the UNESCO Office in Windhoek in the organization of the project's activities, support the UNESCO international expert to carry out her expertise missions and facilitate the continuation of the work of the Namibian national team between the missions.

Please note that the **position of a national expert is not a full-time post**. It is important for the national expert to have flexible availability in order to assist the entire project on a part-time basis. The national expert will be expected to participate in peer-to peer learning by travelling to a knowledge provider partner country to be identified, along with 2-3 other Namibian stakeholders, as detailed below (see section 9, peer-to-peer exchange). The travelling cost relating to the peer-to-peer learning will be provided by the project.

The project implementation in Namibia is expected to be from May 2020 to 31 June 2021. Remote online work via e-mails and videoconferences will be privileged in the first steps of the project.

# **Background information**

Ratified by 145 countries and the European Union, the <u>UNESCO 2005 Convention on the Protection</u> and <u>Promotion of the Diversity of Cultural Expressions</u> (2005 Convention) recognizes the right of governments to adopt regulations, policies and measures to support the emergence of dynamic and strong cultural and creative industries (CCIs). It ensures artists, cultural professionals and creative practitioners, as well as all citizens, have the capacity to create, produce, disseminate and enjoy a broad range of cultural goods, services and activities, including their own.

UNESCO, with funding from the EU, has launched in December 2018 a call for applications to support 12 countries in their efforts to establish new regulatory frameworks for the CCIs and provide for South-South peer-to-peer learning and exchange opportunities. A project submitted by the Ministry of Education, Arts and Culture of the Republic of Namibia has been accepted by the EU/UNESCO Steering Committee. This project seeks to create a measure to support local content production and the revision of a copyright legislation taking into account the digital environment.

Drawing upon the expertise requested by Namibia, a national expert is expected to work closely in pair with an international expert from the <u>EU/UNESCO Expert Facility</u> to accompany Namibia in the design of this measure. - 1. Within the framework of the initiative "EU/UNESCO Expert Facility on the Governance of Culture in Developing Countries: Support for new regulatory frameworks to strengthen the cultural and creative industries and promote South-South cooperation", funded by the European Union, a project submitted by the Ministry of Education, Arts and Culture of the Republic of Namibia has been accepted by the EU/UNESCO Steering Committee. This project seeks to create a measure to support local content production and the revision of a copyright legislation taking into account the digital environment.
- 2. In this context and under the supervision of UNESCO, the Consultant shall work as a national expert together with a partner international expert, to assist Namibian authorities in implementing this project. S/he shall accompany the national partner, the Ministry of Education, Arts and Culture of the Republic of Namibia, to produce a comprehensive strategy of intervention to ensure implementation, ownership and sustainability of the expected results as identified by the beneficiary in their request "Designing a measure to support local content production and revising a copyright legislation taking into account a digital environment".
- 3. Throughout the project, the Consultant will:
  - a) Provide regular project management support to the UNESCO Office in Windhoek for the organization of activities;
  - b) Maintain regular contacts with the European Union delegation in Windhoek with a view to ensuring their participation in the project's activities as a project partner;
  - c) Communicate on a regular basis with the national team and UNESCO to provide advice/guidance to the national team, and monitor the progress of the project;
  - d) Maintain regular contacts with the international expert to be selected by the Namibian government and UNESCO, before, during and after her three missions, to discuss the progress and challenges of the project implementation;
  - e) Encourage teamwork within the group, capitalizing on each member's skills and experience and ensuring an adequate transfer of skills and competences;
  - f) Participate in exchange of information among actors involved in the EU/UNESCO project;
  - g) Provide to UNESCO all necessary documents and information in his/her possession on the mission;
  - h) Undertake regular monitoring with the national partner and members of the national team to ensure sustainability to the results obtained;
  - i) Take good resolution photos and audio-visual materials to gather testimonials of the beneficiaries of the project and submit them to UNESCO.
- 4. To this end, the Consultant shall do the following:

## 5. Provision of expertise

#### 6. Preparation

a) Read supporting documents provided by UNESCO and become familiar with the general context of the Convention on the Protection and Promotion of the Diversity of Cultural Expressions; read the application of Namibia to apprehend the objectives and expected outcomes of the project, undertake research to further grasp the current CCI policy landscape, compile all pertinent resources and information available to best understand the context and objectives of the mission, and share them with UNESCO;





- Participate in a tele conference with UNESCO, an international expert and the national partner for the project and define and coordinate the activities to be undertaken as well as the division of responsibilities;
- c) Support UNESCO and the national partner in the elaboration of a work plan, in coordination with the international expert;
- d) Set the date for the first national team meeting, identify the main stakeholders and draft a provisional agenda;
- e) Prepare a work and individual meetings schedule for the first few days upon arrival of the international expert, ensuring that the principal intermediaries will be available.

#### 7. First mission

- a) In coordination with UNESCO, the international expert and the national partner, participate in the first provision of expertise mission throughout the duration of the international expert's stay in the country. The dates and the duration of the mission will be decided in consultation with UNESCO and the national partner;
- b) Organize and participate in a first group meeting with the national team to recall responsibilities and define more precisely the role and forms of interaction between the members of the national team and the experts;
- c) Initiate contact with the main partners and establish working groups, assign roles and tasks, define objectives and outcomes of each working group;
- d) Identify other relevant key official counterparts and contact them in coordination with the local partner (e.g. other ministries and departments, etc.);
- e) Together with the international expert and the national partner, meet relevant policy-makers and/or any other relevant authorities in order to ensure that they are informed of the EU/UNESCO project and its objectives and that they are mobilized to actively participate in the project activities;
- f) Identify and assess precise needs based on the first round of consultations and meetings and also identify the human and institutional resources available, with a view to determining the best modalities to carry out the provision of expertise;
- g) Produce a diagnostics, understood as a "check" against the original demand, based on inclusive consultation with public officials and civil society actors. This will serve to gather views and inputs, agree on objectives and expected results, define feasible outputs and outcomes of the project, and finalize a work plan and timetable;
- h) Work with the national partner, the international expert and UNESCO to fine-tune the results-framework with concrete and measurable performance indicators. The revised results-framework will serve as a base for the monitoring and evaluation of the project implementation in Namibia;
- i) Submit to UNESCO and the national partner a diagnostic report for the implementation of the mission, no later than two weeks after the first mission of the international expert, including a communication plan indicating:
  - the targets of communication activities individuals, groups etc.;
  - information and communication activities and timetable;
  - the nature of the documents and materials to be produced and distributed (information, awareness-raising and content).

#### 8. Second mission

- a) In coordination with UNESCO, the international expert and the national partner, participate in the second mission throughout the duration of the international expert's stay in the country.
   The dates and the duration of the mission will be decided in consultation with UNESCO and the national partner;
- b) Discuss with working groups feasible elements to be included in the draft measure;
- c) Facilitate the drafting and consolidation process;





- d) Present the outputs from the working sessions to the government and receive final directives;
- e) Provide coaching and mentoring after the departure of the international expert to accompany the process for the finalization of the measure.

#### 9. Peer-to-peer exchange

- a) In consultation with UNESCO and the national partner, contribute to identifying and liaising with a knowledge provider partner country with whom the selected national team members will engage in peer-to-peer learning, devise a peer-to-peer learning programme and play a facilitating role in its implementation. The Consultant may travel to the partner country together with selected members of the national team;
- b) Submit to UNESCO a report on the peer-to-peer learning activities including elements on the second provision of expertise mission.

#### 10. Third mission

- a) In coordination with UNESCO, the international expert and the national team, participate in the third mission throughout the duration of the international expert's stay in the country. The dates and the duration of the mission will be decided in consultation with UNESCO and the national coordinator;
- b) Work with the national team on the operationalization of the newly designed measure (including advocacy measures);
- c) Organize capacity building activities on participatory policy design and implementation for the national team;
- d) Provide coaching and mentoring after the departure of the international expert to follow-up on the implementation of the measure;
- e) In coordination with the national team, ensure wide dissemination of the project's results to all stakeholders and potential users through workshops and briefings;
- f) Provide advice to the national team to support the setting up of sustainable inter-ministerial coordination mechanisms. Such mechanisms are indispensable in order to engage stakeholders from various ministries and ensure effective implementation of policies and measures to build regulatory environments, considering that they often cover issues that go beyond the mandate of the Ministry in charge of culture. Such mechanisms will also serve to create policy dialogue between the government and civil society organizations that will be involved in the implementation of the actions;
- g) Submit a final report to UNESCO, focusing on the results of the mission, detailing the success, challenges, recommendations and ways forward associated with the overall intervention strategy and the draft measure, no later than one month following the completion of the third provision of expertise mission of the international expert.

What is a regulatory framework for CCIs and why does it need to be reinforced?	The cultural and creative industries (CCIs) have become a driver and enabler of sustainable development, generating annual global revenues of US\$ 2,250 billion and exports of over US\$ 250 billion. It is estimated that these sectors provide nearly 30 million jobs worldwide and employ more people aged 15-29 than any other sector.
